1. Minutes.

The minutes of the last meeting had been circulated and were confirmed and signed as correct.

The Chairman welcomed Mrs. Carter, who had been re-appointed one of the F.N.I.F. representatives in her new capacity as Technical Adviser on Nursing to the League of Red Cross Societies.

2. Arising out of the Minutes.

a. Applications from students to take special courses.

Reported the following resolution of the Bedford College Finance Committee:

"That £4.4.0 be allowed for the payment of Intercollegiate fees on behalf of Miss Banworth (U.S.A.) and Miss Hofman-Bang (Denmark), two Florence Nightingale International Foundation Students who desire to take lectures in "Mental Hygiene" at King's College, Strand."

b. Course in Psychiatry.

i. Report from the Sub-Committee set up to consider future provision for teaching Psychiatry.

This report had been circulated to the Committee. (Report appended, see Folio). Dr. Mess and Dr. Mace both spoke to it.

After consideration

RESOLVED

that the report be adopted.

that a letter be written to Dr. Alice Hutchison informing her of the termination of her course at Bedford College as from the end of the current session owing to change in arrangements, and expressing the gratitude of the Committee for all she had done in the past for the International Students.

ii. Report on financial aspect.

The Chairman reported that the financial aspect of the new suggestions for teaching Psychiatry had been considered by the Bedford College Council, who had resolved that in the event of the proposals being adopted by the Organisation Committee, Bedford College would agree to the additional expense in payment of Lecturers' fees involved.

Noted.

iii. Recommendation for Lecturer on the medical side.

The question of a Lecturer for the course in Psychiatry on the medical side was considered and proposals were asked for. Dr. Mace recommended that Dr. J.A. Hadfield (King's College) should be invited, and failing him, Dr. Grace Culver (Dr. Hadfield's wife). The proposals were supported by the Committee.

RESOLVED

that in the first place Dr. Mace be asked to approach Dr. Hadfield to ascertain whether there is any liklihood of his accepting an invitation to give the lectures required (10 in number).

Recommended

that in the event of Dr. Mace reporting that Dr. Hadfield would agree, a letter of invitation be sent to him.

Recommended (cont.)

that in the event of Dr. Mace reporting that Dr. Hadfield would be unable to accept such an invitation, a letter be sent to Dr. Culver formally offering her the appointment.

RESOLVED

that subject to the consent of the Lecturer, the lectures be open to all students of the College in addition to the F.N.I.F. Students and that they also be included in the list of lectures open to outsiders on payment of a fee.

c. Arrangements for the Presentation of Certificates, 1939.

Reported that Sir Arthur Stanley had undertaken to invite Mr. Eden to present the Certificates and speak to the students, but had not yet done so owing to the international situation. That Miss Jean Gunn and Miss Bergliot Larsson had been unable to accept an invitation to address the students from the nursing point of view, as neither of them would be in England at the time of the ceremony; that an invitation had now been sent to Miss B.G. Alexander (President-Elect of the F.N.I.F.).

The matter was further discussed and the Committee was generally of the opinion that it was very unlikely that Mr. Eden would undertake to present the Certificates, and it was suggested that Mr. Joseph Kennedy, the American Ambassador, be invited in the first place. It was agreed that the decision must be left to Sir Arthur Stanley.

RESOLVED

that in the event of Sir Arthur Stanley agreeing, Mr. Joseph Kennedy be invited to present the Certificates and speak to the students, and failing him, Mr. Ronald Collet Norman.

3. Communications received.

A letter was read from the College of Nursing reporting that it wished to make a change in the Hospital Administration lectures for 1939-40. The following recommendation was received from the Education Committee of the College of Nursing:

That Captain Brierley of the London Hospital be invited to give a course of lectures on Hospital Administration for the session 1939-40, and failing him either of the following:

F.A. Lyon, B.A. - Seamen's Hospital, Greenwich. Lt.-Col. W. Parkes, - St. Mary's Hospital.

It was further reported that Captain Brierley might not be able to cover the whole syllabus, but that there would be no flifficulty in finding a lecturer or lecturers to fill in the gaps, when it was known how much of the syllabus would be undertaken by Captain Brierley.

RESOLVED

that the recommendation of the College of Nursing be adopted.

4. Report from the Tutor on the Practical Work.

Miss Bridges gave a report on the practical work of the students during the Easter vacation. (For Report, see File 196F).

Later in the meeting and in connection with the practical work Miss Bridges asked the approval of the Committee for the rearrangement of the students' practical work as follows:

2 weeks in the summer) instead (4 weeks in the summer 1 or 2 weeks in January) of (5 weeks at Easter. 5 weeks at Easter)

She pointed out that the students were too strange to England and their work as a whole to get enough advantage out of 4 weeks practical course immediately on arrival, and she thought they would get quite as much benefit from 2 weeks in the summer and even one in January as they did out of the present 4 weeks in August and September. Miss Bridges pointed out that the month of September would, in her opinion, be most usefully spent by 10 days to a fortnight in Manchester Square learning English and adaptation to their new surroundings, followed by a fortnight's practical work.

The matter was discussed and the Committee generally were in sympathy with Miss Bridges' proposal. It was pointed out that the Health Visitors must have 6 weeks' course in the summer in order to comply with the Ministry of Health regulations, and that those students who lacked the English language would still need to come early to improve this part of their equipment.

After further discussion

RESOLVED

that the first term for the F.N.I.F. students start on 1st September instead of the middle of August as hitherto, except for such students for whom special arrangements are made for language or other reasons.

that part of the Christmas vacation be in future devoted to practical work.
