Dear Principal,

I am sorry if the phrase 'so far as the Court are concerned' in my letter of 30 January about the Social Policy and Nursing Course seemed ambiguous to you.

It was inserted in all the "academic initiatives" letters simply in the thought that other factors within Schools quite apart from the question of money and Court approval might delay the implementation of the proposed developments.

I informed the Chairman of the University Grants Committee of all the "special academic initiatives" projects which the Court were proposing to finance some time ago, receiving encouragement in response, and the Academic Department have also "cleared" your Social Policy and Nursing Course specifically with the officers of the Committee under the standing procedure.

Consequently, if there are no problems within the College, the arrangements for the course can go right ahead.

Dear Principal,

I am now able to let you know that, in the light of your letter of 30 October 1979, the Court have confirmed the availability of the earmarked grants of £5,000 in 1979-80, £15,000 in 1980-81 and £20,000 in 1981-82 which were offered in my letter of 24 October 1979 from the Court's special "academic initiatives" provision for the support of the College's proposed four-year degree course in Social Policy and Nursing in conjunction with The Middlesex Hospital School of Nursing. The College is accordingly now free to implement the proposed development, so far as the Court are concerned. I should, however, remind you of the wish of the Court to receive reports on the use of these special sums at the end of each financial year.

I should perhaps also say that the special grants will, of course, be projected on an on-going basis in allocations after 1981-82.
