## International Florence Nightingale Memorial Foundation

Thank you for your letter of May 17th, enclosing:-

- (1) a copy of a Memorandum containing proposals for the foundation of an International Memorial to Florence Nightingale,
- (2) a copy of the resolutions passed by the Executive Committee of the League of Red Cross Societies,
- (3) a copy of the resolution passed by the Council of Bedford College.

With reference to the latter resolution and the enquiry as to whether the College of Nursing will be willing to co-operate with the Council of Bedford College in the organisation of the Courses in the same way as hitherto, I am directed to reply:-

The Council of the College of Nursing will wish to continue its co-operation with Bedford College, but until the Statutes of the Foundation are known it will not be possible to anticipate what form such co-operation may take.
