1. Re Students to be withdrawn from the Course.

RESOLVED that in the view of the Council Miss Sharadabai Naidu is not sufficiently qualified to continue the course and that the League of Red Cross Societies be asked to withdraw her.
that in the view of the Council Miss Mitusi Kintaka is not sufficiently qualified to continue the course and that the ieague of Red Cross Societies be asked to withdraw her.
2. Re students to be allowed a further probationary period.

RESOIVED that in view of the favourable report from her Finglish teacher Miss Natsuye Inouye be allowed to continue the course up to Christmas when her progress be further reported on.
that iss Rotterowna be allowed to continue the course up to Christmas when her progress be further reported on.
that liss Marti be allowed to continue the course until Christmas but it be made clear to her that unless by the end of the current term she has shown very marked improvement she be not allowed to continue beyond this period owing th the danger of lowering the whole standard of the course.
that Miss Ripol Noble be required to continue with her Eospital work until Christmas when her work be further reported on.
that in all the above cases Mrs. Reid be given power to act and report to the Committee concerning the above candidates whom it had been agreed to allow to continue the course for a further probationary period.

RESOLVED
that in addition to routine changes the following changes be made in the prospectus for 1929-30:-
(a) Page 8 Under "Requirements for Admission" the words 'applicants should be between the ages of 21 and $41^{\prime}$ to replace the words "must not be less than 21 years of age."
(b) Page 11 Paragraph 3 last line - to read "tropical nursing at the College of Nursing" instead of 'tropical hygiene'.
(c) Page 14 Under "Required Subjects" - "Principles of Hospital Administration and Training School Administration 26 lectures" to replace sections XIII and XIV.
(d) Page 21 Under section VII, Psychology, delete paragraph $1 b$ and insert on page 22 a new section, number VIII entitled "Tthical Principles and Practical Problems."
(e) Page 24 Changes to bring it into line with changes made on page 14.
that a $\mathrm{n}_{\mathrm{h}}$ 这 bo printed at the beginning of the chapter "Curriculum" page 18 to the following effect:-
"That the names of lecturers are subject to alteration'
4. Re League of Red Cross Certificate.

RESOLVED that the following changes in the League of Red Cross Certificate be approved:-
(a) "Signature of Principal of the College" to become "Signature of the Principal of Bedford College."
(b) That "Prosident of the college of Hunsing" be added to the list of signatories.
that application be made to the League of Red Cross
Socleties that the certificate thus altered should
never be given to any student except on the
recommendation of the comittee for the organisation of Courses for Internatioaal Students.

RESOLVMA that Lady Cowdray be invited to present the certificates.

With regard to the last resolution, I shall presume, unless I hear to the contrary, that the invitation to Indy Cowdray goes from the League rather than from Bedford College.

I shall be glad to hear from you in due course whether the League of Red Cross Societies is prepared to consent to our application with regard to the presentation of the new League of Red Cross Certificates.
