Dear Miss Tuke,

I am enclosing a tentative outline for the proposed course in Public Health Nursing which I discussed with you last week, and which you thought you might possibly be able to arrange for the International students next year. The outline is practically identical with the one we went over together, with the exception of the section on Maternity, Infant and Child care, also the supplementary lectures on Industrial problems. If in the outline on nursing subjects you have or know of lecturers who could be secured for these talks, and if you care to arrange them for other hours than those allotted to nursing subjects, please do not hesitate to do so. The supplementary lectures on tuberculosis and Venereal Disease and so forth could be placed in the theoretical work given by your staff or in the hours arranged by the League representative. In other words I am trying to explain that it will be perfectly agreeable to us to fall in with any arrangements you make regarding hours for the different subjects and that we would be most grateful for any advice or suggestions you care to offer. Any subjects which you fear it would be impossible for you to give, our representative could endeavour to arrange, either by giving them herself, or, with your advice and approval, arranging outside lectures.

I have noted in pencil on the outline the number of hours I would suggest for the various subjects, but these of course would have to be altered so as to suit your curriculum and existing timetable.

Professor C.E.A. Winslow, Director of the Health Department of the League of Red Cross Societies and Professor of Public Health at the Yale University, is now in London and I have asked him to call and make definite settlements with you, if he approves of my suggestion that the International students attend the Bedford College course next year. Subject to an agreement being reached between you and Professor Winslow I should be much obliged if you will fill in the hours and suggest any changes in the outline as soon as possible, so that we can begin securing our students at once.
