

Proposals concerning payment of Tuition Fees between
Bedford College and the College of Nursing.

A.

Fees paid by Bedford College on behalf of Students attending the
College of Nursing.

Existing Procedure.

At present payments made by Bedford College to the College of Nursing are as follows:-

1. Payment of approximately 50% of Miss Bowes's salary.
2. Payment of 15 guineas per student for lectures in connection with the Nurse Administrators course.
3. Payments for all other lectures attended by Bedford College students at the lecture rate charged by the College of Nursing to outside students.

No.2, 15 guineas for Nurse Administrators Course.

It is understood that this fee has up to the present included payment for:-

- a. 10 lectures in Training School Administration (proposed to increase to 20 lectures).
- b. 10 lectures in Hospital Administration.
- c. 10 lectures in History of Nursing.
- d. 10 - 16 lectures in Educational Psychology.

The rate paid to the College of Nursing for the above lectures is more than double that paid for Intercollegiate Lectures. Of the above, a and b are given for Bedford College students only, cost 40 guineas to the College of Nursing; c is duplicated for Bedford College students because time of existing course is not convenient, cost 20 guineas; d, ~~these lectures~~ would be held at the College of Nursing even if there were no Bedford College students.

It is understood that

Proposed Procedure for 1929-30.

- I. That Bedford College ^{above} should guarantee the cost price of those lectures a, b and c not required by the College of Nursing students, and that the College of Nursing should have the advantage of fees obtained by additional outside students joining these classes.
- II. That Bedford College pay the ordinary lecture fees of the College of Nursing for lectures under d at the rate charged by the College of Nursing to members of the College.
- III. That for all other lecture courses attended by students of Bedford College the fee charged be as indicated in II above.

Summary.

If the above proposals are carried out, payments made by Bedford College to the College of Nursing will be as follows:-

1. A fixed payment of 60 or 80 guineas per annum according as the the lectures under a, b and c number 30 or 40 lectures.
2. Payment of ordinary lecture fees as charged to members of the College of Nursing for all other lectures attended by Bedford College students.
3. Payment of approximately 50% of Miss Bowes's salary.

NOTE.

It should be born in mind that when the charge of 15 guineas per student was fixed in 192 it was for 4 students only, and that at this time no contribution was made by Bedford College towards Miss Bowes's salary.

- B. Fees paid by the College of Nursing on behalf of College of Nursing Students attending Bedford College.

That in future College of Nursing students be allowed the benefit of Intercollegiate rates, charges for lectures to be made as follows)-

For a course of 10 lectures £1. 9. 6.

For^a shorter course of lectures in the same proportion as for 10 lectures

This would mean that a course of 6 lectures, hitherto charged for at 1 guinea per student would be 17/9.
