Miss Ruth Marian Hallows entered the Nightingale Training School, St Thomas's Hospital, in July 1919, completed her three years' training in July 1922, and holds the Certificate of the Nightingale Training School, St Thomas's Hospital, dated 15th July 1922, No. 748.

Miss Hallows received her education at Lincoln High School and Lady Margaret Hall, Oxford, and before entering St Thomas's Hospital, she qualified for admission to the University in 1905 taking the Oxford Honour School of English Language and Literature in 1908.

During her training Miss Hallows gained experience in the various parts of the Hospital, subsequently working for the Certificate of the Central Midwives' Board, but, owing to contracting a poisoned finger on the District, was unable to continue the Course. From September 1923 to September 1924 Miss Hallows was Assistant to Sister Tutor during which period she was released for special courses and experience, enabling her to work for the Health Visitors' Certificate which she obtained when working in the special departments of this Hospital and the Venereal Diseases Department. In 1925 Miss Hallows studied at King's College for Women taking the Sister Tutor Course. She subsequently returned to Oxford under the period of grace for old pupils to take the examinations for completion of the Degree course and took her M.A. degree in May 1927.

Miss Hallows has fitted herself to take any educational post. She should be an able lecturer and keen on the development of the educational side of her profession. Owing to her accident her practical experience has been less than one would have desired, but she has amply made up for this, and given more experience, should be a real value in developing the educational side of the Nursing Profession.

Dear Miss Tuke,

After advertisement and out of a large number of applicants the Council of the College of Nursing at its Meeting on the 23rd instant appointed as a whole-time Education Officer Miss R.M.Hallowes, M.A.Oxon., particulars of whose career are enclosed herewith.

Feeling, however, that it would be of great advantage to Miss Hallowes herself and to the College if she were afforded opportunities of gaining wider experience abroad, and particularly in the United States of America, the Council is making application to the Rockefeller Foundation for her to be granted a Travelling Scholarship for a period of six months.

Should this application be successful, it is probable that Miss Hallowes will not take up her duties until about the beginning of next April. The Council therefore appointed as Acting Education Officer in the interim Miss G.M.Bowes, who has recently taken the Hospital Administration Course. It is the hope of the Council that Miss Bowes may be acceptable to the Council of Bedford College as the Tutor for the Nurse Administration Students for the purpose of carrying out the duties indicated in Paragraph a. of the Minutes of the informal Meeting held on June 17th of the newly constituted Committee for the organization of the Courses for International Students. It is intended that Miss Bowes shall give half her time to these duties, and the remainder to her duties as Acting Education Officer. The salary of the Education Officer is £350 plus a contribution to the Federated Superannuation Scheme for Nurses and Hospital Officers, which will bring the total to about £400. It is proposed that half of this sum shall be recouped to the College of Nursing by Bedford College.
