BSC DEGREE IN NURSING STUDIES

As Secretary of the Special Advisory Committee in Nursing Studies, I have received from Mr Chubb a proposal for the following course which you signed on 26 June 1981:

PY14 Human Physiology with basic Human Anatomy (14 cu)

I referred this to the Chairman of the Special Advisory Committee for approval, as it appeared that this version of the course proposal had taken full account of the queries previously raised by the Special Advisory Committee at its meeting in May concerning the academic content/value. The Chairman has, however, asked me to refer to you one further query before the course is given final approval. We understand that the teaching of the Anatomy content of the course (approximately ¼ cu) is to be undertaken by teachers of the Middlesex Hospital Medical School, as Bedford College has no Recognised Teachers in Anatomy. If this is indeed the case, it would seem appropriate to include the name of the Middlesex Hospital Medical School under Section 14 of the form. I am, therefore, writing to seek confirmation that you would agree to my amending the form which you signed in this way.

I would add that the matter is of some urgency, if teaching of the course is to commence this October, since you will be aware of the requirements of paragraph 2.4 of the General Regulations for courses to be approved within nine months of the date of the examination.

BSc NURSING COURSE "HUMAN PHYSIOLOGY WITH BASIC HUMAN ANATOMY"

I am writing further to my letter of 25 September and to a conversation we had a week or so ago. May I remind you that I am still seeking from you, or from Dr Burton (to whom I am copying this letter), confirmation that it is acceptable to Bedford College if a reference is included on course proposal form PY14 "Human Physiology with Basic Human Anatomy" to the teaching of the Anatomy content being undertaken by teachers of the Middlesex Hospital Medical School.
