#### b. Public Health Course.

#### i. Lila Florence Jacob.

Reported that this candidate was not a trained nurse but that she had had a University education, had served a year in the Calcutta Hospital and had taken the Health Visitors' Certificate of the Lady Reading Health School, Delhi; that since the Indian Red Cross were very actively engaged in Child Welfare Work and had difficulty in securing nurses who were well educated, it was recommended that this candidate be admitted under the exception clause.

RESOLVED

that Lila Florence Jacob be admitted to the Public Health Course for 1931-32 under the exception clause.

# ii. Applications from Yugoslavia - Slava Smiljanic Roksanda Cabrinovic.

The Committee were reminded that the papers of these candidates who had applied for admission to the course for Nurse Administrators had been before them at their last meeting but had been deferred for further information on account of their age and lack of administrative experience; that it had been recommended to the Yugoslavian Red Cross that they be transferred to the Public Health Course; that these applications were now before the committee.

Considerable discussion took place concerning the admission of these candidates. It was finally

RESOLVED

that the acceptance of the candidates Slava Smiljanic and Roksanda Cabrinovic from Yugoslavia be deferred until after they have arrived in England and the College authorities have received reports on the practical work which they will do during their first 3 months, July 15th to October, and that if the reports on their practical work after the 3 months do not justify their acceptance that they be not admitted to the Course.
