Dear Miss Monkhouse,

I have returned to the office and found your letter of December 21st, to which I hasten to reply.

With regard to question

(a) I am doubtful if we will be able to secure Miss Johns after all. However, there is still some hope as Mr. Pearce of the Rockefeller Foundation arrives from the States to-morrow, when Miss Crowell will discuss the matter with him. I shall know definitely in a few days. I do not think there will be any difficulty in securing Miss Bridge or Miss Hodgman, should they be willing to undertake it. In the instance of Miss Bridge or Miss Johns the League would certainly be prepared to defray the travelling expenses and offer hospitality. In the event of our not being able to secure either of these, I feel sure that if the Committee strongly recommended it, the League would consider bringing Miss Hodgman from the States, but I have not yet discussed this with the Secretary General. I will probably be able to give you a more definite answer when I come over on January 12th.

(b) I think that we will have to be prepared to pay the usual fees, but I feel sure in certain cases this will not be expected. If the Canadian Red Cross send Miss Jean Browne, which we are asking them to do as she is Red Cross and also an old student, I feel sure that a fee will not be expected, and should the Rockefeller Foundation permit Miss Johns to come, they will almost certainly do it at their own expense. In the instance

of Miss Bridge we should probably have to offer a fee, but I should like to talk this over with you when I come to London.

I do not think the leaders of the discussions would expect fees. We would certainly be responsible for all traveling expenses and hospitality.


