#### 1. MINUTES

#### 2. MATTERS ARISING

#### Membership

To Report: (1) Prof P H Millard, Dept of Geriatric Medicine, St George's HMS, has accepted an invitation to join the SAC.

(2) The Board of Studies in Pathology has nominated its Vice-Chairman, Prof J H L Playfair (MiddxHMS). This nomination will be considered formally by the Academic Council on 3 June.

Royal College of Nursing Commission on Nursing Education (Minute 39 refers)

To Report: The main recommendations of the Commission are:

- to switch the present hospital-based education of all nurses to higher education. Students to be financed through a system of bursaries;
- (ii) the establishment of a three year programme of studies leading to the award of a Diploma in Nursing Studies, to be validated by CNAA,
- (iii) an increase in degree provision from the present 2% to 5%;

#### 9. ACADEMIC STANDARDS

These papers have been prepared by the CVCP, and the Academic Council has asked for the views of Boards/Committees particularly on the proposals for the final examination (Sections 19-22) in the Postgraduate paper.

#### 10. PLANNING FOR THE LATE 1980s

TO REPORT: (1) At its meeting in January, the Joint Planning Committee considered a UGC letter of 19 November 1984 which deals <u>inter alia</u> with the preparation of universities' research plans. The UGC has formed three Working Parties to advise and report by April on these issues relating to research funding across the whole range of academic issues. It is thought likely that in May the UGC will circulate specifications for the preparation of research plans with a request to universities to submit research plans by November. Schools are currently engaged in drawing up provisional plans which will be studied by a Sub-Group of the JPC who will submit the plans to the UGC, tigether with a document drawing the attention of the UGC to the University's research strengths and to the importance of its collaborative endeavours. (2) The JPC is aware that Boards of Studies, along with Special Advisory Committees and Academic Advisory Boards, will be able to make a valuable contribution to the University's statement of the research strengths and ambitions. Unfortunately, because of the tight timetable, the JPC's Sub-Group will have very little time in which to perform its task and it is therefore suggested that if members of Board of Studies wish to draw attention to any points to be included in the University's research plans, they be asked to ensure that the information is communicated directly to their Schools in order that this may be incorporated into their own research plans before submission to the University.

(3) Copies of the UGC's letter of 19 November 1984 have been circulated to Schools. Copies are, however, available from the Secretary if so required.

## Proposal to modify the method of assessment for the half unit Psychiatric Nursing (0746)

This fourth year half unit is currently assessed by course work : three essays, a patient care study, a patient care plan and a clinical assessment.

Experience from marking work and discussions with students in this first year of the course have indicated that most students find the volume of work excessive. Consequently, the three essays in particular have tended to be answered rather superficially because of lack of time. We have also found that the marks for each of the three essays tend to be highly correlated, although care plans and care studies have produced different patterns of marks.

We therefore propose that two rigorous essays would be a less time consuming and more intellectually demanding assessment for final year students than three necessarily superficial essays. The proposed distribution of marks shown below retains the same proportions for each component of the assessment as originally agreed :

## current assessment

essay 1. psychiatric nursing 20%
essay 2. methods of therapy 20%
essay 3. abnormal psychology 20%
patient care study 20%
patient care plan 10%
clinical assessment 10%

## proposed assessment

- essay 1. psychiatric nursing, with methods of therapy 25%
- essay 2. abnormal psychology, with methods of therapy 25%
- patient care study 25%
- patient care plan 12.5%
- clinical assessment 12.5%

#### Dear Chairman

ACADEMIC STANDARDS

In September 1983 the Committee of Vice-Chancellors and Principals set up a group to study universities' methods and procedures for maintaining and monitoring academic quality and standards with a remit which included teaching and research at both undergraduate and postgraduate levels. The group to date has produced three papers: The External Examiner System for First Degree and Taught Master's Courses, External Involvement in the Maintenance and Monitoring of Academic Standards and Postgraduate Training and Research. I will be writing separately about the first paper on the External Examiner System.

External Involvement in the Maintenance and Monitoring of Academic Standards

The Academic and Collegiate Councils have both given preliminary consideration to this paper. It was noted that insofar as this University was concerned external involvement in the monitoring of academic standards was extensive - in examinations, in appointment of professors and readers, in peer review in the Subject Area Review Committees. The CVCP document had however drawn attention to the concept of External Advisory Committees, common in the universities of the USA where there was no general use of external examiners. While recognising the value of external ad hoc enquiries into specific issues there was no conviction that the involvement of External Advisory Committees as a routine element of the External monitoring process would be useful in this University. It was considered, however, that the CVCPs paper should be circulated widely within the University so that there could be adequate opportunity for debate on the issues it raised. I am therefore sending a copy of the paper for the information of your Board/Committee and should they wish to make any comment I will be pleased to receive it.

## Postgraduate Training and Research

The CVCP paper on Postgraduate Training and Research is attached for consideration by your Board/Committee. In circulating this paper for comment the Academic Council has requested that I should draw particular attention to the section on Final Examination, which recommends that a candidate's supervisor should not normally be appointed as an examiner and should not normally attend any viva or meeting of examiners. The present position in the University of London is that Boards of Studies may appoint the supervisor as an examiner if they so wish. Practice varies, but there has been a trend over the past few years for more Boards not to appoint the supervisor as an examiner. This trend has the total support of the Academic Council, although opinion in the Council is divided over whether or not the supervisor should have a right to be present at the viva if he is not appointed as an examiner. The present practice in London is that the supervisor if not an examiner may attend the oral examination as an observer without the right to question the candidate or participate in any way.

It would therefore be particularly helpful to the Council to receive the views of your Board/Committee on the CVCP paper and in particular on the proposals on Final Exminations.

I should be grateful to receive your Board/Committee's response to both CVCP papers by Friday, 7 June 1985.
